

OUR PRIVACY POLICY

The use and security of online data is important to all web users, and we at Quin Art Shop take these issues very seriously. This notice describes our privacy policy. By continuing to use this website, you are accepting the practices described below.

WHAT PERSONAL DATA WE COLLECT AND WHY WE COLLECT IT

When you conduct online transactions at Quin Art Shop, we do require your name and contact information. These details are stored on a secure server, and we will never release any of them to third parties, except where obliged to do so by law. If you would like your personal details to be permanently removed from our records, please contact us and we will be happy to delete them.

We may also use your email address to send you occasional marketing emails, which you will receive no more than four times per year. You can also sign up to these quarterly email bulletins by following the 'Subscribe' links on our website. Every marketing email has an 'unsubscribe' link at the bottom, which allows you to opt out of further emails whenever you choose.

DATA AND PAYMENT SECURITY

Quin Art Shop are committed to ensuring that your personal information remains secure. To safeguard against unauthorised access or disclosure, our website has an SSL certificate. This means that all information transmitted between web server and browser is sent via encrypted links, using industry-standard security technology.

All payments taken on our site are made via a Stripe secure server. Stripe are industry leaders in secure online payment and handle all aspects of the payment transaction. Quin Art Shop does not have access to your credit card information or banking details at any stage of the payment process.

COOKIES

Industry-standard cookies are also used on our website. A cookie is a small file that asks permission to be placed on your computer's hard drive. By using our website, you agree to these cookies being used. Cookies help to analyse web traffic and allow web applications to respond to you as an individual by remembering information about your browsing preferences.

Quin Art Shop uses traffic log cookies to identify which pages are being viewed, and we use Google Analytics to help analyse this traffic data. This helps us to improve the functionality of our website, by monitoring which pages you find useful and which ones you do not. We

only use this information for statistical analysis purposes, then the data is removed from the system.

Cookies do not give us access to your computer or any information about you, other than the data you choose to share. You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can modify your browser setting to decline cookies if you prefer. This may prevent you from taking full advantage of our website.

LINKS TO OTHER WEBSITES

Quin Art Shop website contains social media sharing tools and may occasionally include links to other websites of interest. Please note however that once you click these links you leave our site, and we do not have any control over the websites you are directed to. We cannot be responsible for the protection and privacy of any information you provide whilst visiting these other sites, and such sites are not governed by this privacy statement. HOW LONG DO WE RETAIN YOUR DATA?
